**<u>Recommendation:</u>** Staff recommends approval of the Second Supplemental Agreement with BHC Development, LLC.

**Background:** This agreement is the culmination of discussions encompassing the last four (4) years regarding three (3) items related to the original Development and Operations Agreement with the developer for the Boot Hill Casino. The issues addressed bring a written finality to two (2) issues and remove pre-determined apportionments of development costs for future development in the area of the Casino.

<u>Justification</u>: The orderly retirement of certain issues in the Development and Operation Agreement and the encouragement of future development in the area.

Financial Considerations: None anticipated.

Purpose/Mission: Improving and strengthening the quality of life.

**<u>Legal Considerations:</u>** The proposed Agreement has been negotiated and reviewed by legal counsel.

**<u>Attachments:</u>** Proposed Second Supplemental Agreement.

#### SECOND SUPPLEMENTAL AGREEMENT

THIS SECOND SUPPLEMENTAL AGREEMENT is made this \_\_\_\_\_ day of \_\_\_\_\_\_, 2015 by and between BHC Development, L.C. ("BHC") and City of Dodge City, Kansas and the County of Ford County, Kansas to supplement and modify that certain Development and Operation Agreement executed in September, 2009 by and between BHC Development, L.C., a Kansas limited liability company ("BHC") and the City of Dodge City, Kansas and County of Ford County, Kansas ("City/County") relating to certain real estate, upon which the Special Events Center and the Casino have been constructed, known as Lots One (1) and Two (2) of the final plat of Mariah Center Replat, a Replat of Mariah Center, Lot One (1), Block One (1), a subdivision of land in Dodge City, Ford County, Kansas, along with certain adjacent real property (the "Development Agreement"), and the Supplemental Agreement dated October 13, 2009 by and between BHC and City/County (the "Supplement").

WHEREAS, City/County and BHC wish to supplement and modify the Development Agreement and the Supplement; and

WHEREAS, this Second Supplemental Agreement (this "Second Supplement") modifies and supplements the Development Agreement and the Supplement.

NOW THEREFORE, in consideration of mutual covenants and agreements hereinafter set forth and in furtherance of the goals and objectives of the Development Agreement and the Supplement, the parties do hereby agree as follows:

- All capitalized terms used herein shall have the meaning ascribed thereto in the Development Agreement except and unless specifically defined within this Second Supplement.
- 2. This Second Supplement enhances, clarifies and makes more certain various aspects and procedures for carrying out the terms and provisions of the Development Agreement and the Supplement. Thus the documents are to be read in conjunction with each another, with the purpose and the intent of the parties as set forth in these three (3) documents to be carried out herein, provided, however in the event of any conflicts between this Second Supplement, the Development Agreement and the Supplement, this Second Supplement shall control.
- 3. The parties agree that the Sections 13.3(b) and (c), as well as Exhibit E to the Development Agreement, are now null and void, and will be of no further effect.
- 4. The parties agree that all obligations and responsibilities of the parties pursuant to Section 3.3 of the Development Agreement have been satisfied and completed, and the parties are discharged and released from any further

obligations and responsibilities pursuant to Section 3.3 of the Development

5. The parties agree that all obligations and responsibilities of the parties

pursuant to Paragraph 5 of the parties' Supplemental Agreement dated

October 13, 2009 have been satisfied and completed, and the parties are

discharged and released from any further obligations and responsibilities

pursuant to Paragraph 5 of the parties' Supplemental Agreement dated

October 13, 2009.

6. The parties agree that this document is not to be recorded in the public records

but will be made available as required by law. The terms hereof are to remain

obligations of the parties hereto. Notwithstanding the above it is the intent of

each of the parties that this Second Supplement will be binding upon any

successors in interest to either the BHC Tract or the SEC Tract and each of the

parties hereto agree to provide for and assure the assumption and adoption of

this Second Supplement by any successor in interest to any portion or all of

either of the BHC or SEC Tracts.

Agenda Item:New Business

**Recommendation:** Approve quote from Building Solutions LLC, for the construction of two driveways' associated with the McDonald's development at Village Square Mall in the amount of \$49,952.50.

<u>Background:</u> This project is Phase 1 of the overall Central Ave. Improvements. These improvements will add a Two-Way Left Turn Lane (TWLTL) to Central Ave. from San Jose Dr. to just south of US 50. The San Jose Dr. and Central Ave. Intersection will be realigned and a traffic signal installed.

<u>Justification</u>: As part of the McDonald's development at Village Square Mall, the City will be making the fore mentioned improvements to Central Ave. Part of these improvements include the installation of two driveways for the McDonald's development.

**Financial Considerations:** The construction of Phase 1 of the Central Improvements will cost \$49,952.50. Funding of this project will be from CID approved through Ordinance 3609 at the July 20, 2015 Commission Meeting. The quote from Building Solutions LLC. is \$107.50 above the Engineer's Estimate.

**Purpose/Mission:** This project will continue the City's Core Value of Ongoing Improvements to provide for the community's future.

<u>Legal Considerations:</u> By approving the quote with Building Solutions LLC., the City will enter into a contract and be responsible to make payments to Building Solutions LLC., for the completed work.

<u>Attachments:</u> The quote tabulation for Building Solutions LLC and JAG Construction Co., which includes the Engineers' Estimate.
